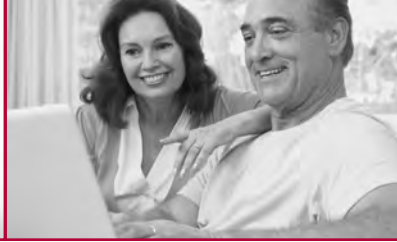

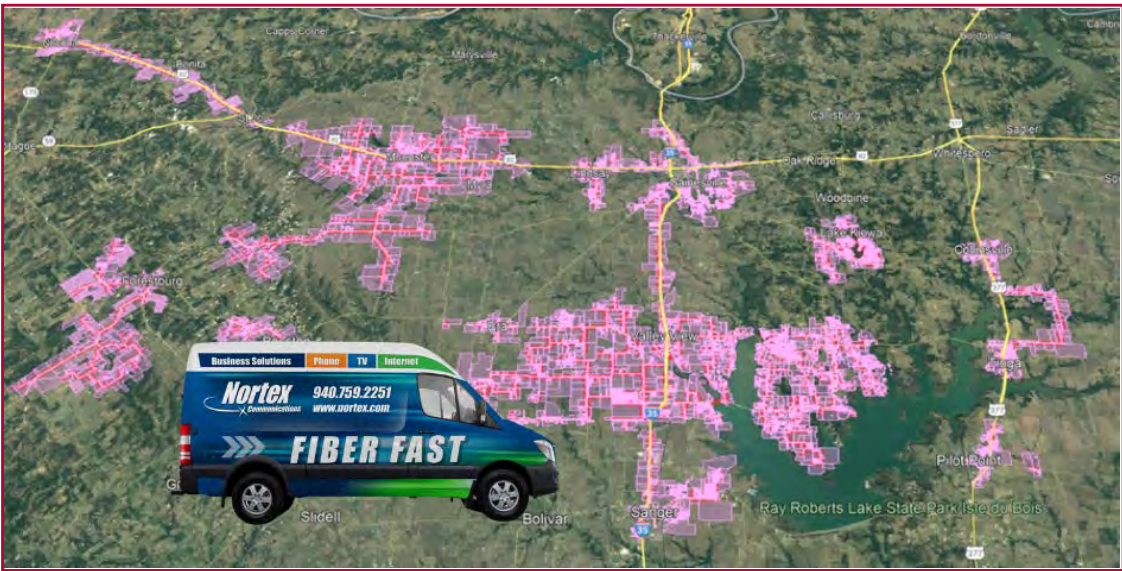

10-DIGIT DIALING

The Federal Communications Commission (FCC) has adopted 988 as a new three-digit number to be used nationwide to reach the National Suicide Prevention and Mental Health Crisis Lifeline.

To complete local calls, all customers in the 940 area code will need to dial the area code followed by the 7 digit telephone number.

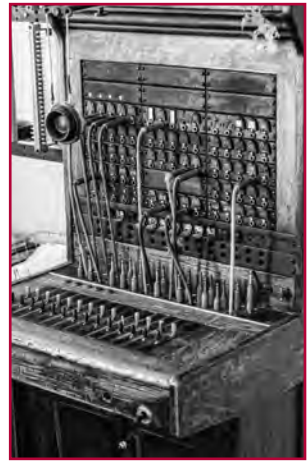

Muenster was a town getting ready to explode with new technology. Imagine the sounds of the telephone operators as they sat at their switchboard stations connecting calls from one person to another. Run your fingers over the markings left by former operators as they spent their time connecting calls and listening to stories of long ago. Follow along with owner, Alvin Fuhrman as he narrates the stories of many of the operators who sat at the original switchboards located in the museum. Listen as he tells the adven-

tures of himself as a young man in the telephone industry. See photos of the ice storm that destroyed the telephone lines with the weight of the ice not once but twice. Finally, take a closer look at the telephone directories when the numbers were one or two letters of the alphabet with specific coding to be connected to the correct person.

GENERAL INFORMATION

THINGS YOU NEED TO KNOW ABOUT TELEPHONE SERVICE

UNDERSTANDING YOUR TELEPHONE BILL

The following are items that can be found on your local telephone bill. Each item originates either from Nortex Communications' local exchange tariff that is regulated by the Public Utility Commission of Texas or comes from state or federal mandates.

Residential Access Line Charge (Basic Local Service)

This charge allows access to the local exchange service area in accordance with the provision of Nortex's tariffs.

Expanded Local Calling

This charge was created through a balloting of customers and allows customers to have a larger local calling scope to encompass particular communities-of-interest that would be located outside the normal calling area.

Interstate Toll Access

(FCC Subscriber Line Charge)

This charge recovers interstate costs associated with the local portion of the telephone network.

Equalization Surcharge

This fee funds the provision of 9-1-1 emergency & poison control telecommunications services.

Texas Universal Service Fund Surcharge

This surcharge allows affordable service to high-cost rural customers, funds the Relay Texas and Specialized Telecommunications Assistance programs for the hearing-disabled, and funds telecommunications services discounts to low-income customers.

Federal Universal Service Fund Surcharge

This surcharge funds telecommunications services discounts to schools, libraries, rural health care providers, and low-income customers. It also provides funds to local telephone companies that serve rural and high-cost areas. Assessed on interstate long-distance charges at percentages that vary by long-distance carrier.

State and Local Sales Tax

These taxes are levied on tangible personal property and taxable services, including telecommunications services. The state tax rate is 6.25%, and the total of all local taxes cannot exceed 2.0%.

ABUSE OR FRAUDULENT USE OF TELEPHONE SERVICE

The tariffs provide for suspension or termination of telephone service for abuse or fraudulent use. Abuse or fraudulent use includes the use of Telephone Company service or facilities to transmit a message, locate a person or otherwise give or obtain information without payment of a Long-Distance charge. Abuse or fraudulent use also includes charging a Long-Distance call to a false number, to an unauthorized credit card number or to another number without permission. For your protection, new equipment and procedures enable the Telephone Company to detect and investigate fraudulent use of telephone facilities. Federal and state laws provide that no person shall defraud the Telephone Company of its lawful charges. Violators, upon conviction, are subject to imprisonment, fine or both.

GENERAL INFORMATION

THINGS YOU NEED TO KNOW ABOUT TELEPHONE SERVICE

DIRECTORY ACCURACY

Every effort is made to make the directory as accurate as possible. In case of error or omission the liability of the Company, if any, is limited to the amount of actual impairment of the customer's service and may not, in any event, exceed the amount paid for the service during the period covered by the directory in which the error or omission occurred.

DIRECTORY ASSISTANCE

For local numbers not listed in the telephone directory, dial 1 plus 411 and ask for listing. One free call is allowed. After that, a charge is associated with each Directory Assisted call. Charges are determined by your long distance carrier.

IDENTIFICATION

OF TELEPHONE EMPLOYEES

Our installers and repair personnel wear photo ID badges to identify themselves as Nortex employees. Call our office at (940)759-2251 should you have questions or concerns.

LOCAL CALLS

You must dial all ten (10) digits including the Area Code of the telephone number to complete a local call.

Basic local (exchange) telephone monthly rates are for the access line only.

SERVICE CONNECTION CHARGES

The one-time service charges for installing and rearranging telephone service, which are in effect in all locations, are based on a multi-element plan under which the customer pays the charge for the elements associated with the work performed in connecting or rearranging service.

The service charge is divided into four parts:

1. Service order charge applies when a change occurs in the account records.
2. When central office wiring must be placed or changed or your line reprogrammed for a change in service.
3. Trip charge for each trip not caused by the telephone company.
4. Drop Charge. When a line to a house is placed or rearranged.

Additional information concerning service connection charges is available through the local business office.

HOME WIRING MAINTENANCE OPTIONS

Inside wiring is all the wiring inside of your home or business and includes your telephone outlet and jacks.

For your continued convenience Nortex will offer an inside Wire Maintenance Agreement on simple inside wiring for a monthly charge of \$3.00 for each

exchange access line terminating at your residence. Please contact the telephone company business office for installations and a maintenance agreement.

If you need maintenance or installation of inside wiring and do not have an inside Wire Maintenance Agreement, you now have three options:

1. Hire Nortex Communications to do the work.
2. Hire another contractor.
3. Do the work yourself. Nortex has the materials for sale, or you can purchase them from numerous retail stores.

If you choose Nortex to do the work, you will be billed for labor plus materials. The labor charges are based on the current hourly rate for Premise Work Charges in 30-minute increments. There is a one hour minimum charge per trip.

If the telephone company repairman is on your premises and you want him to work on your house wiring, you will be billed a 30 minute minimum charge, plus materials. These charges are in addition to the service order charges and any other telephone company applicable charges.

When Nortex completes the work, you receive a 30-day warranty against defects and malfunctions. All Nortex charges and rates are subject to change without notice.

MAINTENANCE OF COMPLEX BUSINESS SYSTEMS

Maintenance service for wiring for Key Systems and other business multi-line telephone systems will be performed upon request at the complex wiring rates of Nortex.

NEW INSTALLATIONS

When you plan to build or remodel a building or home, call the telephone company business office and our experienced personnel will be glad to assist you in arranging for the proper wiring of your building or home to best serve your needs.

During construction, before interior walls are completed, the wiring can be concealed inside of the walls to all locations where you may desire a telephone or other equipment. After construction is completed the wiring installation may be on the outside of the walls and not be as neat.

Our personnel can often make helpful suggestions regarding your present and future needs.

If you hire a contractor to do the wiring for you, it will be subject to inspection and/or approval by Nortex prior to connection of local exchange facilities.



TROUBLESHOOTING

REPAIR SERVICE

Nortex Communications is still responsible for the maintenance and repair of the telephone lines to your home or business. It is important to try to make sure the problem is not in your telephone set. Nortex Communications is not allowed to repair telephone sets. If we make a customer requested service call and determine the problem is caused by your telephone set or sets and not by our facilities, you will be billed \$30.00 to cover the cost of the service call. If the problem is not in your telephone set, please call Nortex at 940-759-2251.

DETERMINING IF THE PROBLEM IS IN YOUR TELEPHONE SET

1. Look for symptoms like cracked plastic housing, broken or frayed cords or lights that don't work.
2. If you have more than one phone, make sure each phone's receiver is on the hook. If none of them are off of the hook, unplug every phone. Then start plugging them back into the wall jacks one at a time, checking each phone for a dial tone as you go. The telephone set that causes the line to go dead is the broken one.
3. If you have just one phone, unplug it and borrow someone else's that you know is working and plug it into your line. If the borrowed phone works, then the problem is in your telephone set.
4. If the phone(s) appear to be in good working order, call the Nortex Repair Service between 8:30 AM and 5 PM, to help isolate the problem while you are on the line.

IF THE PROBLEM

IS IN YOUR TELEPHONE SET

Leave the broken telephone unplugged.

Nortex Communications is still responsible for the maintenance and repair of the telephone lines to your home or business. It is important to try to make sure the problem is not in your telephone set or the inside wiring in your home or business, because if we come to your home or business and find the problem is inside, we will have to charge you \$30.00 for each repair visit. If you have determined that the problem is not in your telephone set, contact the Nortex Repair Service.

IF THE PROBLEM

IS IN NORTEX COMMUNICATIONS LINES

Again, if you've determined that the trouble is not inside your home but in the telephone line, please call the Nortex Communications Repair Service. If you have reported that you are unable to make or receive calls and your line is out of order for more than eight normal working hours from the time of the report, you are entitled to a credit on your next bill for part of the local service charges. If the adjustment doesn't appear on your next bill, please call Nortex at 940-759-2251.

Nortex Communications recognizes the rights of its customers as a consumer of its services. The following is a list of often asked questions and their answers regarding your rights as a customer, application, billing and payments, deposits and the use of telephone service:

Nortex Communications provides telecommunications services without discrimination to a customer's race, nationality, color, religion, sex or marital status.

1. CAN I LOOK AT AND/OR OBTAIN COPIES OF THE RULES AND RATES APPLICABLE TO TELEPHONE SERVICE BEFORE I APPLY FOR SERVICE?

YES. The information contained in the General Exchange Tariff is a matter of public record. The Telephone Company will make available to the public at each of its business offices all of its tariffs currently on file with the Public Utility Commission of Texas in Austin. The Telephone Company will assist seekers of information and afford inquirers an opportunity to examine any of the tariffs upon request. The Telephone Company will provide copies of any portion of the tariffs at a reasonable cost to reproduce such tariffs for a requesting party.

2. HOW LONG DO I HAVE TO PAY MY TELEPHONE BILL AFTER I RECEIVE IT?

Your bill for local, toll and miscellaneous service is issued monthly and is due and payable at the payment offices of the Company on or before the due date which is sixteen (16) days after issuance.

Your bill for telephone service will become delinquent if unpaid by the due date. The postmark, if any, on the envelope of the bill, or an issuance date on the bill, if there is no postmark on the envelope, shall constitute proof of the date of issuance. If the due date falls on a holiday or weekend, the due date for payment purposes shall be the next work day after the due date.

3. ON WHAT BASIS CAN THE TELEPHONE COMPANY DISCONNECT MY SERVICE?

Your telephone service may be disconnected for any of the following reasons:

1. Failure to pay a delinquent account for basic local telephone service or failure to comply with the terms of a Deferred Payment or Guarantee Deposit Agreement;
2. Violation of the Telephone Company's rules pertaining to the use of service in a manner which interferes with the service of others or the operation of nonstandard equipment, if a reasonable attempt has been made to notify you and you are provided with a reasonable opportunity to remedy the situation;
3. Failure to comply with deposit or guarantee arrangements where required by the Telephone Company in accordance with the General Rules pertaining to Deposits in the General Exchange Tariff for the Telephone Company.

4. WHAT DO I HAVE TO PAY TO PREVENT THE DISCONNECTION OF BASIC LOCAL SERVICE?

To prevent disconnection of basic local service, you must pay the total amount due for all local services as indicated on the bill. However, failure to pay your total amount due will lead to the blocking of long distance access until full payment is received.

5. CAN THE TELEPHONE COMPANY DISCONNECT MY SERVICE WITHOUT NOTIFYING ME BEFORE DOING SO?

YES. If a known dangerous condition exists which would cause harm to the telecommunications network, you as a customer, or employees of the Company, as long as the condition exists.

Also, where service is connected without authority by a person who has not made application for service or who has reconnected service without authority following termination of service for nonpayment or in instances of tampering with the Company's equipment or bypassing it.



6 IF I AM LATE WITH PAYMENT OF MY BILL, WILL THE COMPANY NOTIFY ME? (BEFORE THEY DISCONNECT MY SERVICE)

YES. If your bill for telephone service has not been paid within the 16 days allowed for payment, a termination or disconnect notice will be sent to you at least 10 days prior to a date stated on the disconnect notice that service will be disconnected if the bill has not been paid by that date.

The notice will have the words "Termination Notice" or similar language prominently displayed on it. The notice will also have printed on it, or attached to it, a notice that if you are in need of assistance with payment of your bill, or are ill and unable to pay your bill, you may be eligible for an alternative program, such as a Deferred Payment Plan, and that you should contact the Business Office of the Company for more information during the hours listed at the address and telephone numbers stated on page 2 of this directory.

7 IF I GET A TERMINATION NOTICE AND THE DISCONNECTION DATE SHOWN ON IT IS ON A WEEKEND OR A HOLIDAY, WILL MY SERVICE BE DISCONNECTED ON THE DAY BEFORE?

NO. If the cutoff day falls on a weekend or holiday, the cutoff will be made on the next working day after the tenth day from the date of the notice or twenty-six (26) days from the issuance of your bill.

8 IF I FIND WHAT I BELIEVE TO BE AN ERROR ON MY BILL, HOW DO I RESOLVE THE ERROR? (WITHOUT HAVING MY SERVICE DISCONNECTED?)

In the event of a dispute between you and the Telephone Company regarding any bill for telephone service, the Company will investigate the particular case, and report the results to you.

In the event the dispute is not resolved, the Company will inform you of the complaint procedures of the Public Utility Commission.

Your service will not be subject to discontinuance for not paying that portion of a bill under dispute pending the completion of the determination of the dispute, but in no event should the dispute exceed sixty (60) days. You are obligated to pay any billings not disputed as established in the General Rules Section of the General Exchange Tariff for the Telephone Company.

9 IF MY TELEPHONE BILL IS UNUSUALLY HIGH AND I CANNOT PAY THE ENTIRE BILL, ARE THERE ANY PROVISIONS WHERE I CAN DEFER PAYMENTS OR MAKE MONTHLY PAYMENTS?

YES. You have the right to request a Deferred Payment Plan as a residential customer if you have not been issued more than two (2) Disconnection Notices at any time during the preceding twelve (12) months by the Company.

However, under the Company's Deferred Payment Plan offered due to your inability to pay an outstanding bill in full, you will be required to pay current bills and a reasonable amount of the outstanding bill as well as reasonable installments on the balance until the bill is paid, otherwise your service will be discontinued according to standard disconnection procedures. A payment of up to one-third (1/3) of the deferred amount will be required as a reasonable payment.

If you do not fulfill the terms of the Deferred Payment Plan, the Company will have the right to disconnect your service upon issuance of a Disconnection Notice to you, as provided in these rules, indicating you have not met the terms of the plan.

10 SUPPOSE MY TELEPHONE SERVICE IS DISCONNECTED, WHAT SHOULD I DO TO HAVE IT RECONNECTED?

1. If your service has been disconnected for failure to establish credit or failure to pay basic local service, you must pay your bill or enter into a Deferred Payment Plan and meet the Company's deposit requirements before service will be restored. A charge for restoration of service will be made and collected by the Company.
2. If your check was returned because of insufficient funds or other reasons, you must make payment good. If the Company deems money order or cashier's check and not accept a personal check if your credit history warrants such action. A restoration of service charge is applicable under this condition.
3. If your service has been terminated and your deposit applied to the balance of your account, it will be necessary to reapply for telephone service as a new applicant.



YOUR RIGHTS AS A CUSTOMER

11 IF I DON'T AGREE WITH ACTION OR DETERMINATION OF THE COMPANY REGARDING ITS CUSTOMER SERVICE RULES OR RULES OF THE PUBLIC UTILITY COMMISSION, HOW DO I GET THE DISPUTE RESOLVED?

If there is a dispute between you and the Company, you may request and be given an opportunity for supervisory review by the Company.

If the Company is unable to provide a supervisory review immediately after your request, arrangements will be made for the earliest possible date. Your telephone service will not be disconnected pending completion of the review. The results of the review will be provided to you within ten (10) days after the review if you so request.

If you decide not to participate in the review or make arrangements for such review within five (5) days after requesting it, the Company will disconnect your service under its standard disconnect procedures.

Should any disputes not be resolved after the supervisory review, any complaints you may have can be directed to the Public Utility Commission of Texas in writing to the following address:

12 UNDER WHAT CIRCUMSTANCES WILL I BE REQUIRED TO PAY A DEPOSIT IN OBTAINING TELEPHONE SERVICE?

Every residential and business applicant or customer must establish satisfactory credit with Nortex Communications to receive telephone service.

If you cannot provide a satisfactory credit reference or do not have a good payment record or cannot provide a guarantee satisfactory to the Company, customers may be required to make a deposit to receive service. Access for residential customers to basic local service will be considered separately from long distance. Therefore, deposits for basic local service will be determined based on basic local charges.

Business customers without satisfactory credit history will be required to make a deposit for both basic and anticipated long distance charges.

13 IF I AM REQUIRED TO MAKE A DEPOSIT TO HAVE TELEPHONE SERVICE, CAN I BE REQUIRED TO PAY AN ADDITIONAL DEPOSIT TO KEEP MY SERVICE?

To receive basic local service, residential customers will only be required to submit a deposit equal to the cost of two month's of basic local service. No additional deposit can be required for this service. However, access to long distance may require additional deposits.

To require such deposit, your actual usage must be three (3) times estimated usage (or three (3) times average usage of most recent three (3) bills), and your current usage must exceed \$150, and must exceed 150% of the security held.

The request by the Company for such an additional deposit shall be made to you in writing and will advise you that you have the option to elect to pay the current usage in lieu of the additional deposit.

If the additional deposit or current usage payment is not made within 10 days, after issuance of the written notice of termination and requested additional deposit, the Company may disconnect your service.

If you are a residential customer and actual billings are at least twice the amount of estimated billings after two (2) billing periods and a suspension notice has been issued on a bill in the previous twelve (12) month period, an additional deposit may be required to be made within fifteen (15) days after issuance of written notice or termination and requested additional deposit, OR if you are a business or commercial customer and actual billings are at least twice the amount of estimated billings and a suspension notice has been issued on a bill within a previous twelve (12) month period, an additional deposit may be required to be made within fifteen (15) days after issuance of written notice of termination and requested an additional deposit.

In lieu of payment of the additional deposit, you may elect, as either a business or residential customer, to pay the current billing by the due date of the bill, provided you have not exercised this option in the previous (12) months.



14 IF I AM REQUIRED TO PAY A DEPOSIT, WHAT RATE OF INTEREST WILL BE PAID AND HOW WILL IT BE PAID?

The Company will pay interest on all deposits made by its customers at an annual rate no lower than 0.12% and no higher than twelve (12) as set for each calendar year by the Public Utility Commission of Texas. The Commission established an interest rate of 0.12% for calendar year 2013.

Payment of the interest on the deposit shall be made annually if requested by you, or sooner if your service is discontinued, or credited to your account.

The deposit will draw interest at the established rate from the time the deposit is made to the date the deposit is returned or credited to your account.

15 IF I AM REQUIRED TO MAKE A DEPOSIT, IS THE COMPANY REQUIRED TO RETURN IT TO ME?

1. The Company will issue a receipt of deposit to you for the deposit received and keep a record of the deposit;
2. If service is not connected or if service is disconnected, the deposit will be automatically refunded plus accrued interest for the balance, if any, in excess of the unpaid bills for service furnished;
3. If you are a residential customer and have paid bills for service for twelve (12) consecutive billings without having service disconnected for nonpayment of a bill and without having more than two (2) occasions in which a bill was delinquent, and you are not delinquent in the payment of current billing, the Company will automatically refund the deposit plus accrued interest in the form of cash or credit to your monthly billing. If you have a guarantee for payment of your account, the Company will void and return the guarantee to the guarantor;

4. If you are a business or commercial customer and have paid bills for service for twenty-four (24) consecutive billings without having service disconnected for nonpayment of bill and without having more than two (2) occasions in which a bill was delinquent and you are not delinquent in the payment of current billing, the Company will promptly refund the deposit plus accrued interest in the form of cash or credit to your billing for service.

16 UNDER WHAT CONDITIONS MAY I OBTAIN TELEPHONE SERVICE WITHOUT PAYING A DEPOSIT?

Every customer applying for telephone service with the Telephone Company must establish satisfactory credit. This may be done in several ways and you will not be required to pay a deposit if:

1. You have been a residential customer of a telephone company within the last two (2) years, and,
 - a. You are not delinquent in payment of your account for service, and,
 - b. During the last twelve (12) consecutive months of service did not have more than one (1) occasion in which your bill for service was paid after becoming delinquent and never had service disconnected for nonpayment. (You are encouraged to obtain a letter of credit from your previous company.)
2. You furnish a satisfactory credit rating by appropriate means, including, but not limited to, the production of generally acceptable credit cards, letters of credit reference, the names of credit references which may be quickly and inexpensively contacted by the Telephone Company, or ownership of substantial equity.
3. You furnish in writing a satisfactory guarantee to secure payment of bills for your telephone service.
4. You are an applicant for residential service who is sixty-five (65) years of age or older and do not have an outstanding balance with any telephone company for residential service which accrued within the last two (2) years.



YOUR RIGHTS AS A CUSTOMER

17 HOW WILL THE CREDIT HISTORY OF MY FORMER SPOUSE WHO SHARED MY TELEPHONE SERVICE AFFECT MY CONTINUING TO HAVE SERVICE?

The Company will apply the credit history for you and your former spouse who shared the service equally for a reasonable period of time. Credit history maintained by one, the spouse or former spouse, shall be applied equally to the other without modification and without additional qualifications not required by the other.

Credit history shall not relieve either party as a customer of the Company from complying with the Company's rules for prompt payment of bills.

18 HOW WILL I KNOW ABOUT THE COMPANY'S RULES AS RELATED TO MY SERVICE, ESTABLISHING AND MAINTAINING CREDIT, BILL PAYMENT AND DISCONNECTION OF SERVICE FOR FAILURE TO MAKE PROMPT PAYMENT?

Every six (6) months the Company will provide a statement printed on your bill or a billing insert showing the location of "Your Rights As A Customer" in the Telephone Directory which the Company will furnish you each year or when you have service installed. Information pertaining to service or billing may be obtained by calling the Company's Business Office at 940-759-2251.

19 CUSTOMER RELATIONS

If my sight or hearing is severely impaired, how can I obtain assistance in using the telephone?

Customers having such disabilities should contact the Company's Business Office for information regarding readers or Braille as may be available or for the telephone number of the teletypewriter for the deaf at the Public Utility Commission.

If I have physical disabilities or require care from others, how will I find out about my rights as a customer?

The Company encourages customers with physical disabilities and those who care for such customers to identify themselves to the Company so that special action can be taken to inform these persons of their rights, where necessary and appropriate to the person's circumstance.

If You Receive Obscene or Nuisance Calls, Follow These Suggestions:

- Hang Up
- Give no information
- Advise children to do the same

Making threatening, obscene, or nuisance calls is a violation of state and federal laws. If you receive a threatening call, report it immediately to the police. Many optional phone services—including Caller ID-Number, Call Block and Call Tracing—are available in most areas and can help prevent annoying calls. For further information about these services, see the Calling Features section located on pages 28-36. Often, changing your telephone number will resolve the problem.

BILLED NUMBER SCREENING

Billed number screening has been implemented throughout the United States and all telephone numbers of the Muenster and Valley View systems have been screened not to allow third number calls. If you need to make these calls, the screening can be changed but, we suggest you use a calling card instead, and the rate will be cheaper. For additional information, please call the Nortex business office.

CALL BEFORE YOU DIG

Before you do any extensive digging or construction on your property or public lands, please call 811 to prevent damage to underground utilities. (You must give 48 hours advance notice excluding weekends and holidays). **The following information will need to be provided by the customer:**

- County, City
- Section & ¼ Section number
- Callers name and firm
- Firm address
- Can be reached phone number
- Best time to call
- Location of proposed excavation
- Type and extent of work
- Starting time and date

Then they will let you know if you will run into any telephone lines. All too often, private homeowners and construction crews unintentionally dig up land where these lines and cables are located. This sometimes results in costly damage or destruction. So let's work together to avoid needless disruption of telephone service in our community.

800/877/888/900 NUMBERS

When an 800 or 900 number is dialed from your telephone, your telephone number may be transmitted to the company you have called and may be available to that company's service representative before your call is answered.

It is important to remember that both per-call and per-line blocking will not block your billing telephone number to Emergency 911, nor will it currently prevent your number from being transmitted on 800, 877, 888, or 900 calls. Also, calls made from a pay phone cannot be blocked.



YOUR RIGHTS AS A CUSTOMER

RULES FOR AUTOMATIC DIAL ANNOUNCING DEVICES

Your Telephone Company complies with the rules of the Public Utility Commission of Texas governing the use of Automatic Dial Announcing Devices.

These rules include the following:

1. An Automatic Dial Announcing Device is any equipment used for telephone solicitation or collection that:
 - a. is capable of storing numbers to be called or has a random or sequential generator capable of producing numbers to be called; and
 - b. is capable, alone or in conjunction with other equipment, to convey a prerecorded or synthesized voice message to the number called.
2. An Automatic Dial Announcing Device (the device) may not be used unless the user has obtained a permit from the Public Utility Commission and has given a copy of such permit as written notice specifying the type of device to be connected, to each telecommunications company or cooperative over whose system the device is to be used;
3. The device is not to be used for random number dialing or to dial numbers by successively increasing or decreasing integers;
4. The message conveyed by the device, or a message delivered by a human, must state the nature of the call and the name, address, and call-back telephone number of the person, company or organization making the call;
5. The device must disconnect from the called person's line no later than five (5) seconds after the called person hangs up;
6. No calls shall be made to emergency telephone numbers of hospitals, fire departments, law enforcement offices or other entities providing emergency service;
7. For calls terminating in the State of Texas, the device is not to be used to make a call:
 - a. On a Sunday before 1:30 p.m. or after 9 p.m., or before 9 a.m. or after 9 p.m. on a weekday or a Saturday, when the device is used for solicitation; or
 - b. At any hour that collection calls would be prohibited under the Federal Fair Debt Collection Practices Act, 15 United States Code, Section 801 et seq., when the device is used for collection purposes; and
8. A Violation of any portion of this section shall subject the user to prosecution for a Class C misdemeanor

as set forth in Section 87B(f) of the Public Utility Regulator Act.

Failure to comply with these rules may result in the refusal of service or termination upon proper notice by the Company until noncompliance is corrected.

The above rules do not apply to the use of an Automatic Dial Announcing Device to call a person who has given the person making the call written permission to be called by an Automatic Dial Announcing Device except that the Company may disconnect service to a person using the device if the device is causing network harm.

RECORDING OF TELEPHONE CONVERSATIONS

If your telephone conversation is recorded, the following conditions and procedures shall apply:

1. The recording shall be preceded by verbal or written consent of all parties to the telephone conversation, or
2. The recording shall be preceded by verbal notification which is recorded at the beginning, and as a part of the call, by the recording party, or,
3. A distinct beep tone is heard on the line every fifteen (15) seconds during the course of the telephone conversations when the recording device is in use.

No recording device shall be used unless it can be physically connected to or disconnected from the telephone line or switched on and off.

Under certain restrictions, an exemption to these rules exists for Federally-Licensed Commercial Broadcast and Law Enforcement Agencies.

PRIVACY POLICY REGARDING THE COLLECTION AND USE OF A CUSTOMER'S SOCIAL SECURITY NUMBER

Nortex Communications recognizes the importance of protecting your personal information and are committed to safeguarding your privacy.

Because Nortex respects its customers and understands that they are concerned about their privacy, we have instituted a policy to ensure that your personal

information is handled in a safe and responsible manner. Following are some questions and answers that outline our procedures regarding your privacy.

How your social security number is collected.

We obtain your social security number when you apply for new service or upgrade your service. (If your social security card number is not on file).

How your social security number is used.

Your social security number is obtained because we will be extending credit to you by billing you after the services have been provided to you. We also use your social security number as an additional means to verify your identity and distinguish you from other customers with the same or similar name and to administer the LITE-UP Texas Program.

How do we protect your social security number?

We are sensitive to your concerns that your social security number might fall into the wrong hands, which could result in identity theft or general access to your personal information by unauthorized persons.

Your Application for service, and any other documents containing your social security number, are filed in a secure location to which only a limited group of authorized personnel have access. Personnel who receive your application have strict instructions to immediately transport such documents to the secure area and to not permit such documents to remain on desks, in baskets or elsewhere in general work areas where they could be seen by unauthorized personnel. Personnel are prohibited from copying or in any way duplicating documents containing your social security number except duplication by instruction of authorized personnel for an authorized purpose.

Your social security number does not appear in electronic form accessible on our network by any employees not authorized to have access to your social security numbers. Firewalls, passwords and other safeguards have been installed in our network to restrict access to your social security number to those employees so authorized. Employees authorized to have access to your social security numbers are prohibited from saving your social security number, in any fashion, on the hard drive of any laptop or other stand alone computer not saving data on our network.

We will not include your social security number on any documents, such as monthly statements, for which it serves no purpose. We need your social security number on file for the purposes stated but will not use it unnecessarily so as to limit the opportunity for it to be inadvertently disseminated.

All employees who will come in contact with your social security number are provided initial training before they are permitted to handle any document containing social security numbers and will be reminded, through periodic updated training, of the importance of protecting the privacy of social security numbers and our policies which have been designed to insure such protection,

asserting the need to safeguard customers' social security numbers. Before discarding any customer records, employees are to shred any portion of the records which contain a customer's social security number.

Who can access your social security number?

Personnel, or clerical staff who open mail, will have access to documents containing your social security number.

If your account is turned over for collection purposes and the attorney/collection agency requests your social security number to assist in collection proceedings, we will provide your number to them as our agent.

If we receive a subpoena or Court Order compelling us to turn your records over to a law enforcement agency or investigator or to a party in connection with a legal proceeding, then we will release them, including your social security number, as required by law. If the subpoena is issued in a civil matter, you should have the opportunity to seek a protective order or to quash the subpoena to protect the confidentiality of your information.

How will we eventually dispose of your social security number?

Once you terminate service and pay all amounts owed to us on your account, you may request that we destroy any records containing your social security number. Upon such request, such documents will be shredded and any electronic records will be permanently deleted.

If no request is received from you after service is terminated and fully paid for, we will retain your records in accordance with our record retention policy and this privacy policy. We will destroy your records in accordance with our policy, the records containing your social security number will be shredded and any electronic records containing your social security number will be permanently deleted.

TELEPHONE SOLICITATION

Texas laws provide certain protections for a person who receives a telephone solicitation at a residence.

A telephone solicitor must:

- identify himself or herself by name
- identify the business on whose behalf he or she is calling
- identify the purpose of the call
- identify the number at which the person or company making the call may be reached.

A telephone solicitor may not call a residence before 9 AM or after 9 PM on weekdays and Saturdays or before noon or after 9 PM on Sunday.

If a telephone solicitor uses an automatic dialing/announcing device, the machine must disconnect from your line within (5) seconds after termination of the call.continued on next page

YOUR RIGHTS AS A CUSTOMER

Exceptions: The requirements above do not apply to telephone solicitations made at your request, or solicitations made in connection with an existing debt or contract, or calls from a telephone solicitor with whom you have a prior or existing business relationship.

If you use a credit card to purchase (goods or services) from a telephone solicitor other than a public charity (an organization exempt from federal income tax under the Internal Revenue Code, §501 (c)(3)), the seller must:

- offer a full refund for the return of undamaged and unused goods within seven days after you receive the goods or services (the seller must process the refund within 30 days after you return the merchandise or cancel your order for undelivered goods or services); or
- provide you with a written contract fully describing the goods or services being offered, the total price charged, the name, address, and business phone of the seller, and any terms and conditions affecting the sale.

The Texas Attorney General investigates complaints relating to a violation of this law, which is found at the Business and Commerce Code, Chapter 37. **If you have a complaint about a telephone solicitor whom you believe has violated this law, contact:**

Another law found in The Public Regulatory Act of 55.151 and 55.152, requires a telephone solicitor to make every effort not to call a consumer who asks not to be called again. Complaints relating to a violation of this law are investigated by the Public Utility Commission of Texas.

Be advised that you may have additional rights under federal law. Please contact the Federal Trade Commission or the Federal Communications Commission for further information on the additional rights.

YOUR RIGHTS CONCERNING CUSTOMER PROPRIETARY NETWORK INFORMATION

In December 2007, new rules governing your CPNI went into effect. The new rules are designed to safeguard your information from 'pretexters' who are unscrupulous dishonest people who impersonate you in an effort to gain access to your account information.

It is referred to as Customer Proprietary Network Information, (CPNI), which is the data that is collected and recorded on your telephone account in our billing system. It includes your calling charges, the optional services you subscribed to, your usage data and calling patterns.

Our customer service representatives are required to ask for answers to certain questions to validate your account or establish a password. This is being required by the Federal Communications Commission (FCC) to protect your personal information.

Nortex is required to validate each person that calls into the office by asking certain questions or asking for your password. The verbal password that you established will allow us to access your account when you call. You will be required to use this password each time you call into our office to ask questions about your telephone account. You will also be required to provide appropriate identification when you come into our office.

Nortex may use your CPNI to market our services to you. However, the Public Utility Commission of Texas has adopted rules stating that Nortex may not use your CPNI to market certain telephone services or features to you if you have requested that the CPNI be considered "restricted" for this purpose. These services or features are those that may be available to you from a source other than Nortex.

If you wish to have your CPNI considered "restricted," give us a call. The restriction will remain in effect until you notify us otherwise. Whether or not you choose to restrict access to your CPNI will in no way affect the provision of any services you subscribe to.

Please note that restricting your CPNI will not eliminate all of our marketing contacts with you. You could still receive marketing contacts from us that are not based on your CPNI. Also, we are permitted to use your CPNI to contact you about telephone services we offer that are not available to you from another source. Finally, even if your CPNI is restricted, we may still use it to market those telephone services or features that may be available to you from a source other than us if you contact us and ask about those services.

Our customers are valuable to us and we will make every effort to protect your private information and to provide you with the very best customer service. Should you have questions regarding CPNI, call our office during business hours Monday – Friday from 8:30 AM to 5:00 PM at (940)759-2251.

SERVICE COMPLAINTS

Any customer who has a complaint is encouraged to speak to a service representative in the local business office. If the problem is not resolved, he or she may appeal to higher levels of supervision. Customers may also contact the Public Utility Commission, P.O. Box 13326, Austin, TX 78711-3326. Complaints should be in writing and include as much factual information as possible.

YOUR RIGHTS WHEN USING 900 PAY-PER-CALL SERVICE

You have the right to request blocking of all 900 calls. You may obtain this blocking free of charge.

Your local or long-distance telephone service cannot be disconnected for non-payment of charges for 900 services;

Your access to 900 services may be involuntarily blocked if you do not pay legitimate 900 pay-per-call charges;

You should not be billed for any pay-per-call services that do not comply with federal laws and regulations.

SELECTING A TELEPHONE COMPANY-SLAMMING

Telephone companies are prohibited by law from switching you from one telephone service provider to another without your permission, a practice commonly known as "slamming."

If you are slammed, Texas law requires the telephone company that slammed you to do the following:

1. Pay all charges associated with returning you to your original telephone company within five business days of your request.
2. Provide all billing records to your original telephone company within ten business days of your request.
3. Pay your original telephone company the amount you would have paid if you had not been slammed.
4. Refund to you within 30 business days any amount you paid for charges during the first 30 days after the slam and any amount more than what you would have paid your original telephone company for charges after the first 30 days following the slam.

Your original telephone company is required to provide you with all the benefits, such as frequent flyer miles, you would have normally received for your telephone use during the period in which you were slammed.

If you have been slammed, you can change your service immediately back to your original provider by calling your local telephone company. You should also report the slam by writing or calling the Public Utility Commission of Texas, P.O. Box 13326, Austin, Texas 78711-3326, (512) 936-7120 or in Texas (toll-free) 1 (888) 782-8477, fax: (512) 936-7003, e-mail address: customer@pub.state.tx.us. Hearing and speech-impaired individuals with text telephones (TTY) may contact the commission at (800) 735-2988.

You can prevent slamming by requesting a preferred telephone company freeze from your local telephone company. With a freeze in place, you must give formal consent to "lift" the freeze before your phone service can be changed. A freeze may apply to local toll service, long distance service, or both. The Public Utility Commission of Texas can give you more information about freezes and your rights as a customer.

CHARGES ON YOUR TELEPHONE BILL-CRAMMING

Placing charges on your phone bill for products or services without your authorization is known as "cramming" and is prohibited by law. Your telephone company may be providing billing services for other companies, so other companies' charges may appear on your telephone bill.

If you believe you were "crammed," you should contact Nortex Communications at (940)759-2251 and request that it take corrective action. The Public Utility Commission of Texas requires Nortex Communications to do the following within 45 days of when it learns of the unauthorized charge:

- Notify the service provider to cease charging you for the unauthorized product or service;
- Remove any unauthorized charge from your bill;
- Refund or credit all money to you that you have paid for an unauthorized charge; and
- On your request, provide you with all billing records related to any unauthorized charge within 15 business days after the charge is removed from your telephone bill.

If the company fails to resolve your request, or if you would like to file a complaint, please write or call the Public Utility Commission of Texas, PO Box 13326, Austin, Texas 78711-3326, (512) 936-7120 or toll-free in Texas at (888) 782-8477. Hearing and speech-impaired individuals with the text telephones (TTY) may contact the commission at (800) 735-2988.

Your phone service cannot be disconnected for disputing or refusing to pay unauthorized charges.

You may have additional rights under state and federal law. Please contact the Federal Communications Commission, the Attorney General of Texas, or the Public Utility Commission of Texas if you would like further information about possible additional rights.

TEXAS UNIVERSAL SERVICE

You may notice a charge called "Texas Universal Service" on your phone bill. This charge pays for the Texas Universal Service Fund. This fund was created by the State of Texas to help pay for low income customers and customers in high cost rural areas and to serve customers with disabilities. This charge is 24 percent of your bill and is being offset by reductions in in-state long distance charges. SPECIAL PROGRAMS TO ASSIST YOU

RESIDENTIAL TELEPHONE NO-CALL LISTS

The federal government and many states have recently created an opportunity for consumers to reduce unwanted telemarketing telephone calls they receive. Consumers simply register with the National Do Not Call Registry by telephone at 1-888-382-1222. For TTY call 1-866-290-4236. You must call from the phone number you wish to register. You may also register by Internet at www.donotcall.gov. Inclusion of your telephone number on the national Do-Not-Call Registry will be effective three months following your registration. As a result of consumers registering on the national list, telemarketers must remove the registered consumer's name and number from their calling lists and cease calling for five years. The National Do-Not-Call Registry is a free service to consumers.

Consumers in Texas may also register with Texas No-Call, which prevents telephone solicitations to residential and wireless phone numbers from all telemarketers operating in Texas. Consumers may register for the Texas No-Call list in three ways:

1. Online at <http://www.texasnocall.com> for instant registration. Utilize this easy automated method to speed your registration. The site is available 24 hours a day, 7 days a week, 365 days a year. Online registration is now free.
2. Call toll-free 1-866-TXNOCAL(L) (1-866-896-6225) to obtain an application or to register.
3. Send a written request for an application to:

There will be a charge of \$2.25 to register via telephone or standard mail for each residential or wireless phone number(s) to be included in the Texas No Call List. Your registered telephone number(s) will remain on the list for three years from the date your residential or wireless telephone number is first published on the list.

Texas consumers may want to consider registering with the National Do-Not-Call Registry since it covers national telemarketers and the Texas No-Call affects only telemarketers operating in Texas.

The national and the Texas No-Call lists do not prevent all telemarketing calls from being received once a consumer is registered. Both registries contain exemptions on who can continue to telemarket consumers.

Texas No-Call lists are updated every three months. Customers who sign up for a list will be included on the list beginning with the next quarter (Jan. 1, April 1, July 1, Sept. 1).

Texans may file complaints regarding the No-Call list online at www.puc.state.tx.us or by calling the PUC toll-free at 1-888-782-8477 (1-888-PUC-TIPS) to request a form.



PREPAID LOCAL TELEPHONE SERVICE

Prepaid Local Telephone Service (PLTS) is a program that helps customers manage outstanding telephone balances and retain basic local telephone service. The Public Utility Commission of Texas has directed that Nortex provide this service.

PLTS gives eligible customers a one-time opportunity to retain their local service if they are at risk of disconnection of their local service for nonpayment of telephone bills. It also allows residential customers who have been disconnected because of late or unpaid bills to be reconnected. However, all customers have the option to retain basic local service without entering PLTS by ongoing payment of their basic telephone service, PLTS is not available to business customers.

Your Responsibility

To receive this service, you must agree to receive Toll Blocking/Toll Restriction Service, which will prevent you from making long-distance telephone calls or usage-sensitive calls, which include directory assistance, call return, call trace and auto redial. In subscribing to PLTS, you agree not to incur additional charges for long-distance or usage-sensitive services. In addition, you agree not to request additional services from your local telephone carrier other than those included on your PLTS subscription. If you violate the terms of this agreement, you can be disconnected immediately and will not be eligible to receive PLTS again from Nortex.

To subscribe to PLTS, you must also pay up to two months of charges up front. You must arrange a deferred payment plan with Nortex for your outstanding local telephone charges. Payments for these charges will begin with the third billing cycle after you subscribe to PLTS. The monthly payments on this plan may not exceed \$10.00 per month or one-twelfth of the outstanding local debt, whichever is larger.

You must pay your PLTS bill by the date due.

To Subscribe

Please contact Nortex during normal business hours at 940-759-2251 and request PLTS.

If your telephone has been disconnected and you apply for PLTS within 10 days of Nortex Communications mailing of your PLTS eligibility notice, you will not be required to pay the reconnection charge for restoring service at that time. You will be required to pay that charge when you return to basic local telephone service.

In addition to the charges for services listed, customers will be responsible for paying sur-charges or fees required by law or ordinance, including, but not limited to: 911 charges, subscriber line charges, sales tax, Universal Service Fund charges, and Extended Local Calling (ELC) or Extended Metropolitan Service (EMS) if those services are required in their area.

CUSTOMER TELEPHONE ACCESS – RELAY TEXAS

This service relays calls between a person using a TTY or other assistive devices and any other telephone user within the state. The service also allows a person without a TTY to call a TTY user. Specially trained personnel are available 24 hours a day, 7 days a week, to relay the call. There is no extra charge for this service. Calls placed to destinations within the state of Texas will be billed at discounted rates. Long-Distance calls placed through RELAY TEXAS will be billed at the prevailing rates of the carrier selected by the Public Utility Commission to provide this service. LIFELINE ASSISTANCE PROGRAM

The information below was current as of October 2021.

The Lifeline program is a government program established by the FCC and the Texas Public Utility Commission to make monthly telephone service more affordable for eligible low-income individuals. The Lifeline Program for telephone assistance is only eligible to residential customers in our regulated areas of Muenster and Myra.

Hearing impaired customers may access the Relay Texas for TTY service by calling a toll-free number at 1-800-676-3777. There is no extra charge for this service.

TERMS & CONDITIONS OF LIFELINE PLANS

Residential customers of Muenster Telephone Corporation of Texas d/b/a Nortex Communications (“the Company”) who qualify for the Texas Lifeline Program receive a discount of up to \$3.50 on local voice telephony service.

Customers subscribing to qualifying broadband service, or voice service bundled with qualifying broadband service, may receive a federal Lifeline discount of up to \$9.25. In certain instances, federal Lifeline support is available for voice-only service.

ELIGIBILITY OF LIFELINE ASSISTANCE PROGRAM

Based on household income or qualifying assistance programs, a customer may be eligible for the federal Lifeline discount, the state Lifeline discount, or both. A customer’s household is eligible for the Lifeline Program discount if that customer’s annual household income is at or below 135% of the federal poverty guidelines for the federal discount, or 150% of the federal poverty guidelines for the state discount, or if the customer, a dependent, or the customer’s

household participates in one or more of the following:

- Medicaid
- Supplemental Nutrition Assistance Program (SNAP) (formerly Food Stamps)
- Supplemental Security Income (SSI)
- Federal Public Housing Assistance (FPHA)
- Low Income Home Energy Assistance Program (LIHEAP)
- Temporary Assistance for Needy Families
- National School Lunch Program’s free lunch program
- Health benefits coverage under the state Children’s Health Insurance Program (CHIP)

Lifeline service is limited to one discount per household. A household is everyone who lives in the home (including children and people who are not related to the customer) and shares income and household expenses (bills, food, etc.). A customer with Lifeline service may not transfer the Lifeline benefit to any other person. Lifeline is a nontransferable benefit.

To make sure that our customers continuously receive quality service, any service problems can be reported to Nortex Communications twenty-four hours a day, seven days a week. Basic services are offered at the rates, terms and conditions specified in the Company’s tariff on file with the Public Utility Commission of Texas. CALLING FEATURES REQUIREMENTS

Our Calling Features will work with both touch-tone and rotary dial telephones. The instructions on how to use these features are for touch-tone phones. Rotary phones can follow these same instructions, with two exceptions. First, where a * is listed, rotary users must dial 11. And secondly, where a # is listed, rotary users should wait four seconds.

YOUR SWITCHHOOK

Your switchhook is the part of the phone that hangs it up. However, other switchhooks may vary, depending on the type of phone. Please refer to the phone's owner's manual for details.

CALL FORWARDING

Take your calls with you wherever you go

Note: You will be billed for any long-distance calls forwarded outside the local calling area.

WHAT IS IT?

Call Forwarding sends all your calls to another number. Your calls can follow you when you can't be home.

HOW DO I USE IT?

To Use Call Forwarding:

1. Pick up the phone and press *72
2. Enter the number you want your calls forwarded to.

To Turn Off Call Forwarding:

1. Press *73

CALL RETURN

Catch a just missed call with Call Return

Note: Call Return can return certain long-distance calls. If calling long-distance, you will be billed for the call.

WHAT IS IT?

Call Return calls the last number that called you. Even if you don't know the number of who called. And if the line is busy, Call Return keeps trying for up to 30 minutes. When the line is free, your phone rings with a special ring and places the call for you.

You can even receive and make calls while Call Return is at work.

HOW DO I USE IT?

To Use Call Return:

1. Pick up the phone and listen for dial tone.
2. Press *69
3. The number of the last call will be called back.

If busy:

1. Hang up and Call Return will continue trying to get through.
2. When the line is open, you'll hear a special ring (short-long-short).
3. Pick up the phone, the number you are calling back will ring.

To Cancel Call Return:

1. Press * 89

CALL TRACE

Track down harassing calls

Note: There is a charge for each successful trace. The system traces the last incoming call. This includes the number associated with any Call Waiting tones received.

WHAT IS IT?

Call Trace initiates a trace of the last call you received. The numbers from which threatening or obscene calls are made will be provided to the authorities if you wish to file a complaint.

HOW DO I USE IT?

To Use Call Trace:

1. Hang up after receiving an offensive call.
2. Wait 10 seconds, then pick up your phone and listen for a dial tone.
3. Press *57. If the trace is successful, and if you decide to have the trace acted upon, contact Nortex at 940-759-2251.

If a call cannot be traced, an error announcement will be received.

CALL WAITING

Make sure you don't miss the important calls

WHAT IS IT?

Call Waiting alerts you with a special tone so you know there is an incoming call when you are already on the line. You can put the first caller on hold and answer the second call.

HOW DO I USE IT?

To Use Call Waiting:

1. When you're on a call, you'll hear a special tone signaling that someone else is trying to reach you.
2. To take the call, press the telephone switchhook for one second and release. This also puts the first call on hold.
3. Press the switchhook again to switch between calls.

CANCEL CALL WAITING

Prevent interruptions of important calls, faxes, or Internet access

WHAT IS IT?

Cancel Call Waiting temporarily turns off Call Waiting for uninterrupted calls. This is useful when making long-distance calls or using your computer modem.

HOW DO I USE IT?

To Use Cancel Call Waiting:

1. Before you make your call, press *70
2. Wait for the dial tone, and make your call.
Cancel Call Waiting is in effect for that call only.
3. It is back on again after the call.

CALL WAITING ID

Know who that 2nd caller is even while on the phone

Note: Some calls may not be available. This only occurs when name and number information is not delivered.

WHAT IS IT?

You are on the phone and you hear the Call Waiting tone. Should you respond to it? With Call Waiting ID, you will know who is calling you, even while on the phone. You only answer the most important calls.

HOW DO I USE IT?

To Use Call Waiting ID:

1. You must have a Call Waiting ID box or phone capable of displaying Call Waiting ID information. Also, you must have ordered the service from Nortel.
2. When you are on the phone with one caller, you will hear a tone indicating that a 2nd call is coming in.
3. Look to your call identification screen to see who the 2nd caller is.
4. If you want to speak to that person, press and release your switchhook like any other call waiting call.

2. Plug in the box between your phone and the outlet.
3. Wait for a call. The name and/or number of the person calling is displayed.

DO NOT DISTURB

Block all calls from reaching you

WHAT IS IT?

Need some peace and quiet? Do Not Disturb blocks all calls from ringing at your phone. Only callers who have a special identification code can get through on the line.

HOW DO I USE IT?

To Use Do Not Disturb:

1. Pick up the phone and press *78
2. Listen for three beeps.
3. Hang up.

To Turn Off Do Not Disturb:

1. Pick up the phone and press *79
2. Listen for three beeps.
3. Hang up.

To Set Or Change Your PIN:

1. Dial *10 and listen for 3 beeps and a steady dial tone.
2. Enter a PIN (up to 7 digits).
3. Dial * and listen for 3 beeps.
4. Hang up.

CALLING FEATURES

HOW TO USE YOUR PHONE FEATURES

PER CALL BLOCKING

Block your Caller ID information from specific calls

Note: Per Call Blocking will not block your information when dialing either 911 or when dialing 800 or 900 number calls.

WHAT IS IT?

Per Call Blocking prevents the person you are dialing from seeing your Caller ID information; therefore, hiding your identity and your telephone number.

HOW DO I USE IT?

To Use Per Call Blocking:

1. Pick up the phone and press *67.
2. Wait for the dial tone, and make your call.
Per Call Blocking is in effect for that call only.
3. It is turned off again after the call.

PER CALL BLOCK RELEASE

Only forwards calls from certain numbers

WHAT IS IT?

If you have a non-published phone number, your Caller ID information is not transmitted to the person you are calling. However, if you would like that information released, you can use Per Call Block Release. This feature allows your Caller ID information to be sent to the person you are calling on a per call basis.

HOW DO I USE IT?

To Use Call Block Release:

1. Pick up the phone and press *82.
2. Wait for your dial tone, and make your call.
Per Call Block Release is in effect for that call only.
3. It is turned off again after the call.

PERSONAL RINGING

Know who a call is for by its ring

WHAT IS IT?

Personal Ringing lets you know if a call should be answered or who should answer it, just by the ring. Up to 2 telephone numbers are assigned to the same line. Each one has its own special ring.

HOW DO I USE IT?

How It Works:

1. Personal Ringing gives you up to 2 different telephone numbers, each with its own ringing pattern, all on one line.
2. The main number has a long ring. The second number has two short-rings and the third number will have a short-long-short ring.
3. These special ringing patterns let you know which phone number the caller is trying to reach.

PREFERRED CALL FORWARDING

Only forwards calls from certain numbers

Note: You will be billed for any long-distance calls forwarded outside the local calling area.

WHAT IS IT?

Preferred Call Forwarding sends calls from up to 3 numbers. Your calls from select callers can follow you when you can't be home.

HOW DO I USE IT?

To Use Preferred Call Forwarding:

1. Pick up the phone and press *63.
2. Listen to instructions.

To Turn Off Preferred Call Forwarding:

1. Press *83
2. Listen for instructions.
 - To turn off the service but save the list, hang up.
 - To remove all the numbers on the list, press 08, then hang up.

HOW TO USE YOUR PHONE FEATURES

PRIORITY RINGING

Don't miss special callers

Note: An automated voice will repeat the number so you can check its accuracy.

WHAT IS IT?

Priority Ringing identifies important callers (or those you want to screen) with a distinctive ring. When you receive calls from one of up to 6 selected numbers, your phone will signal you with a special ring. You can then decide whether to answer the phone or not.

HOW DO I USE IT?

To Use Priority Ringing:

1. Pick up the phone and press *61
2. Follow the instructions.

To Turn Off Priority Ringing:

1. Pick up the phone and press *81
2. Follow the instructions.
 - To turn off the service but save the list, hang up.
 - To remove all the numbers on the list, press 08, then hang up.

REPEAT DIALING

Keep dialing that last dialed number, automatically

WHAT IS IT?

Repeat Dialing calls back the last number that you called, whether you received a busy signal or need to re-contact that person. If the line is busy, Repeat Dialing keeps trying for up to 30 minutes. When the line is free, you are notified with a special ring.

HOW DO I USE IT?

To Use Repeat Dialing:

1. Pick up the phone and press *66
2. The number of the last outgoing call will be automatically dialed.
3. If busy, hang up and you will be notified when the line is free.

To Turn Off Repeat Dialing:

1. Pick up the phone and press *86
2. Listen to the notification that Repeat Dialing is canceled.

SELECTIVE CALL BLOCKING

Stop unwanted calls

Note: An automated voice will repeat the number so you can check its accuracy.

WHAT IS IT?

Selective Call Blocking rejects calls from up to six specific numbers. The last number that called you can also be added to the list to prevent them from calling you again. Calls from numbers on the list hear a recorded message saying you are not accepting calls. Your phone doesn't ring.

HOW DO I USE IT?

To Use Selective Call Blocking:

1. Pick up the phone and press *60
2. Listen for instructions.

To Turn Off Selective Call Blocking:

1. Pick up the phone and press *60
2. Listen for instructions.
 - To turn off the service but save the list, hang up.
 - To remove all the numbers from the list, press 08.
 - To remove all private entries on the list, press 09.

SPEED CALLING

Put important numbers at your fingertips

Note: Speed Calling is also available that allows up to 30 numbers instead of 8.

WHAT IS IT?

Speed Calling dials local or long-distance numbers with just one or two buttons.

HOW DO I USE IT?

To Use Speed Calling:

1. Write down the numbers of those you want to set up for Speed Calling, using the numbers 2-9.
2. Press *74
3. Wait for the dial tone and enter the Speed Calling Code (from 2-9).
4. Now enter the phone number for that Speed Calling code (include 1 if it is a long-distance number).
5. Hang up, then repeat steps 2-4 for each number.

THREE-WAY CALLING

Three-Way Calling lets you be in two places at one time

WHAT IS IT?

Three-Way Calling connects you with two people in two different locations at the same time. Or, you can put one person on hold while talking to another.

HOW DO I USE IT?

To Use Three-Way Calling:

1. Call the first person and put them on hold by pressing the switchhook for one second and release.
2. Wait for the dial tone and then enter the telephone number of the person you want to add to the conversation.
3. Press the switchhook again and release to add the first person. Now all three are on the line at one time.
4. To disconnect one caller, ask them to hang up.

TOLL CONTROL WITH PIN

Limit access to long-distance calling

WHAT IS IT?

Toll Control With PIN blocks all long-distance calls from being made from your phone, unless you know a 1 to 7-digit personal identification number. Local and incoming calls are unaffected.

HOW DO I USE IT?

To activate barring for a long distance call through the handset:

1. Dial the access code *341
2. An announcement confirms that call barring has been activated.

To deactivate barring for a long distance call through the handset:

1. Dial the access code *351
2. An announcement prompts you to enter your PIN code.
3. Enter your PIN code.
4. An announcement confirms that call barring has been deactivated.

To Change Your PIN Number:

1. To access the PIN change service, press *319
2. When prompted, enter your current PIN.
3. If the current PIN is correct, you are prompted to enter a new four-digit PIN.
4. An announcement confirms the new four-digit PIN.

CALLING FEATURES

VOICE MAIL - WHAT IS IT AND HOW CAN IT HELP YOU.

Everywhere busy people are adding Voice Mail to their local phone service. Voice Mail responds to your calls when you are unable to answer the phone or when you are currently on the line. It invites callers to leave a message and stores it in your own private voice mailbox. Callers may leave a message at anytime, even several callers at once.

BENEFITS OF VOICE MAIL

- Your phone is answered when you are on the line or away from the phone.
- Family mailboxes allow private messages to be left for each family member.
- You can access your voice mailbox using any Touch-tone phone, anytime, anywhere.

- Voice Mail can activate another phone and/or pager to notify you of urgent messages.
- Callers can review, append, or discard a message before it is actually saved in your voice mailbox.

- Voice Mail requires no special equipment or connections in your home.

With direct-distance dialing you can dial station-to-station long-distance calls to telephone numbers which have ten-digit numerals. You may also dial person-to-person, collect and calling card calls – see instructions below. For other types of long-distance calls, see page 38.

STATION-TO-STATION CALLS

DIAL 1 + AREA CODE + NUMBER

PERSON-TO-PERSON, COLLECT AND CALLING CARD CALLS

DIAL 0 + AREA CODE + NUMBER

After you have dialed the number, an operator will answer and request the details necessary to complete your call.

Person-to-Person Calls: give the name of the person you are calling

Collect Calls: say “collect” and give your name

Calling Card Calls: give your calling card number

TO OBTAIN THE DISTANT AREA CODE

Area codes for some cities are on pages 42 or 43. If the place you want is not listed, dial “OPERATOR.”

TO REACH LONG-DISTANCE

DIRECTORY ASSISTANCE

DIAL 1 + AREA CODE + 555-1212

- Tell the operator the city or town, then the name or place you want.
- There may be a charge for information calls.
- Nortex is not responsible for the accuracy of Directory Assistance.

YOU WILL NOT BE CHARGED

- If you hang up before you dial the complete number.
- If the telephone number you dial is busy or does not answer. Some long-distance companies charge if it rings more than one ring.

On Dial-Direct calls, you pay only for the minutes you talk. The initial rate period is one minute any time of day or night.

CALLING CARD AND OPERATOR-ASSISTED ONE-MINUTE RATES

Calling Card calls cost more than Dial-Direct, but less than Operator-Assisted calls. Operator-Assisted calls are those requiring the assistance of an operator to complete the call.

The initial period for all Calling Card and Operator-Assisted calls is one minute. The initial period is charged at Dial-Direct rates, including discounts applicable to the time period when you call, plus a service charge.

Additional minutes are charged at Dial-Direct rates, and include the same discount applicable to the time period when you call. Discounts do not apply to service charges.

VERIFY BUSY AND INTERRUPT

When you encounter a busy signal, you can have the Operator verify the line to determine if there is conversation. You will be charged for the service whether or not conversation is detected.

If there is conversation, you can request the line be interrupted. The Operator will interrupt the line and determine if the speaking customers are willing to terminate their conversation. The charge for interrupt services applies whether or not the existing call is terminated.

When both Verify Busy and Interrupt are provided on the same call, only the interrupt charge applies.



TYPES OF CALLS

SUBSCRIBERS ARE RESPONSIBLE FOR ALL TOLL CALLS FROM THEIR TELEPHONE.

STATION-TO-STATION

Call station-to-station if you will talk with anyone who answers. Rates are lower than person-to-person. Charging begins when the called telephone answers. Rate is lowest when you dial direct.

PERSON-TO-PERSON

Call person-to-person when you must talk to a particular person or extension telephone. Rates are higher than station-to-station. Charging begins when the called person or extension answers.

COLLECT

Most calls can be made "collect" if the person you are calling agrees to pay the charge. If you want the call made collect, please be sure to tell the Operator when you give the Operator the number.

CONFERENCE

You can talk with several people in different places at the same time. Tell the long-distance Operator you wish to make a conference call.

RATES

RATE DISCOUNTS AND APPLICATION PERIODS WITHIN YOUR LATA

Discounts of 25% for evening and 40% for night are applied to the sum of the day initial period and additional minute charges.

HOLIDAY RATES

New Year's Day, July 4th, Labor Day, Thanksgiving, Christmas Day – On these legal holidays the evening rate applies all day on Dial-Direct calls unless a lower rate would normally apply (nights & weekends).

LONG-DISTANCE COMPANIES

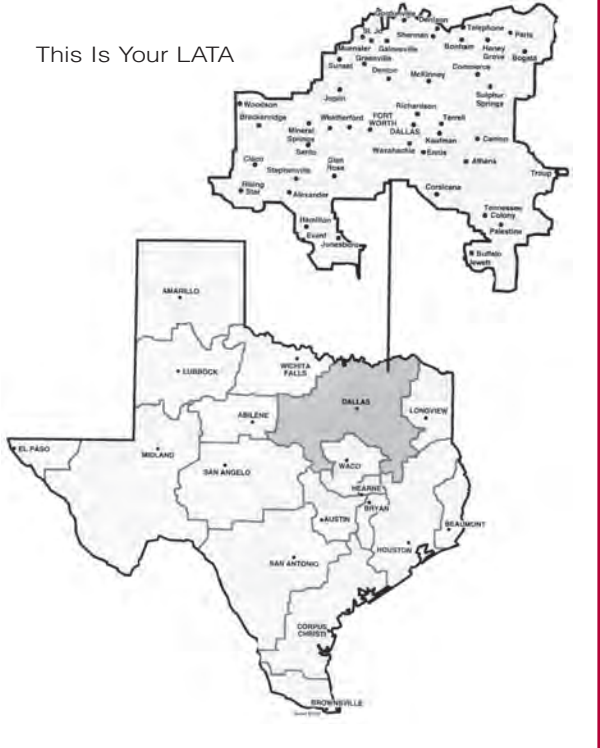
All phone subscribers may select a long-distance carrier of their choice for all 1 + calls. This choice should be made for all calls within the local long-distance calling area, or LATA (see map below) and outside this local area. The local calling area includes one-way calling to the Wichita Falls and Dallas LATA only if you use Nortex Long Distance. The Wichita Falls and Dallas LATA are shaded on the map below

You can select a long-distance carrier by contacting our business office at 940-759-2251. You can also access a particular long-distance carrier on a per-call basis by dialing 101+ the Carrier Identification Code (CIC Code) plus 1 and the number you want to dial. The CIC Code is a 4-digit code that is available from the carrier's customer service department.

When selecting a long-distance carrier, you should look at the following features:

- Can you call anywhere or only certain areas or locations?
- What are the company's rates? Are there monthly fees? Initial charges? A minimum monthly charge? Per-call charges?
- Does the long-distance company discount certain times of day? What are the rates for the time periods and places you call most often?
- Does the company charge for individual calls by blocks of time? By the minute? By portions of minutes?
- How and when will you be billed? Will you be billed separately or by your local telephone company?
- Does the company offer a calling card to use when you are away from home?

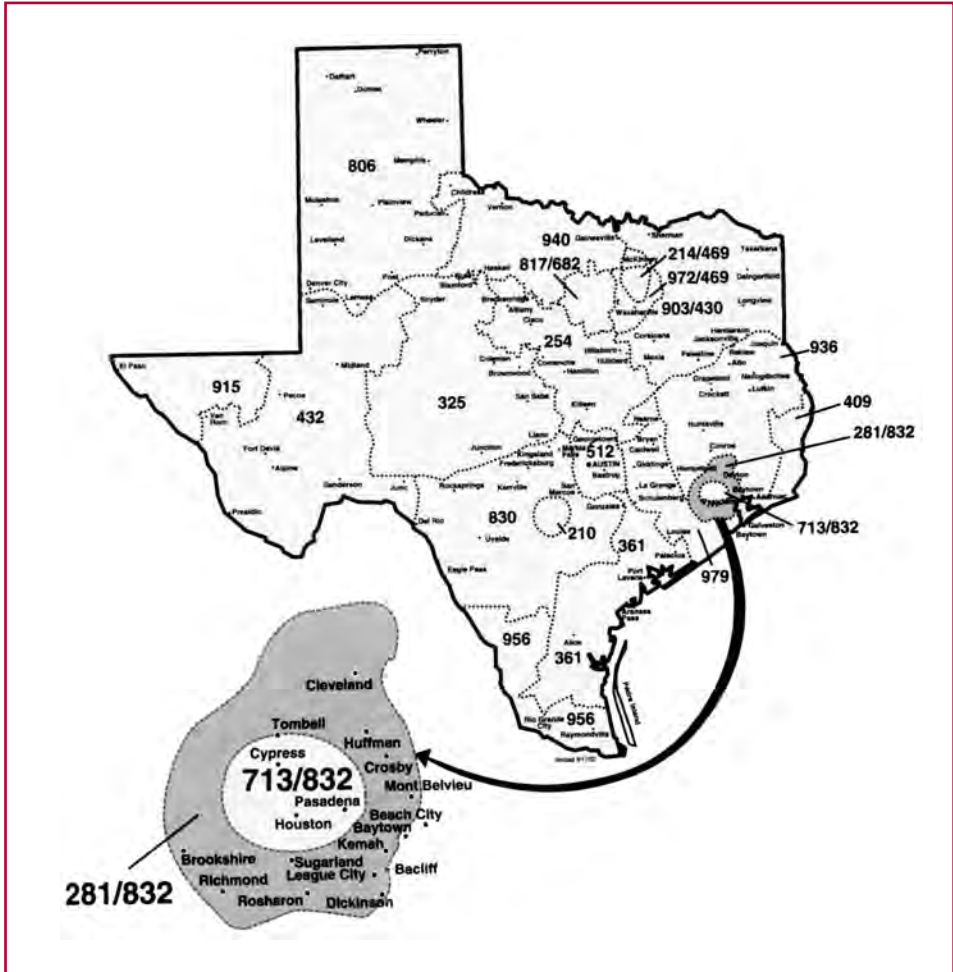


AREA CODE MAP

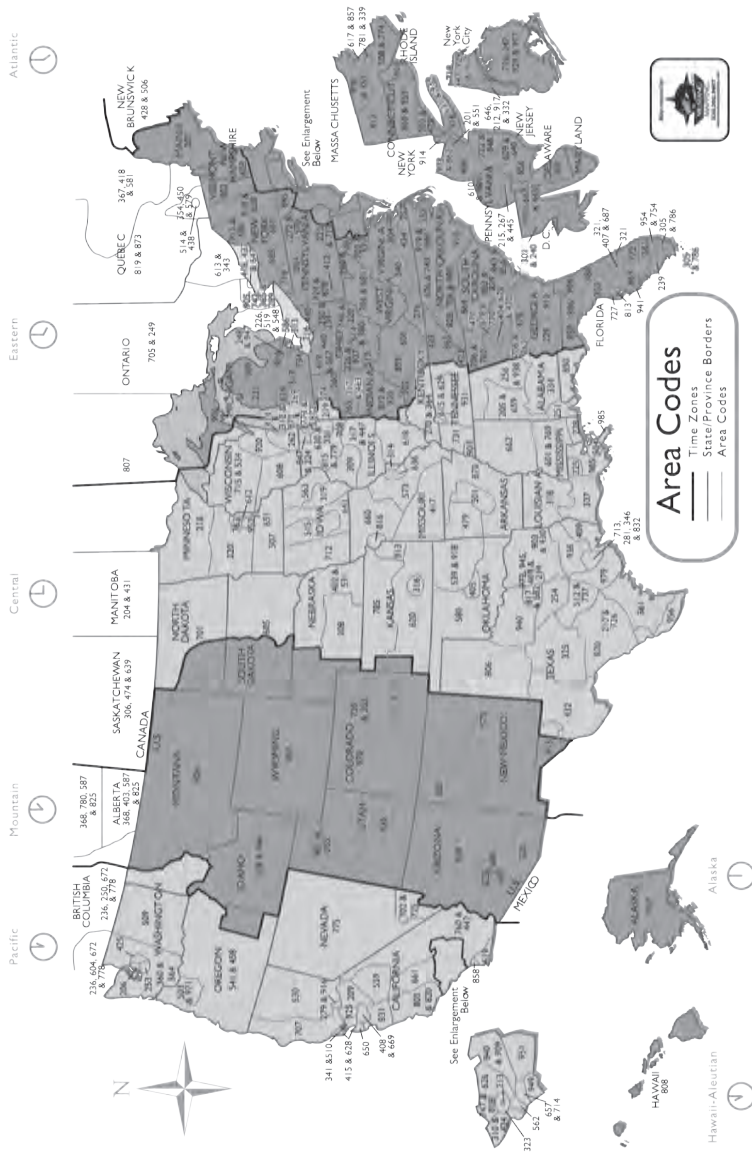

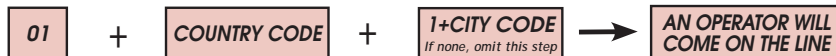
